• V3 Information

Opening and Pledge of Allegiance

Chair Rich Schollmann welcomed everyone and called the meeting to order at 11:07 a.m.

Mr. Al Pianalto led the trustees in the Pledge of Allegiance.

Roll Call of Trustees and Quorum Determination

With 12 of 18 members or their authorized representatives present, a quorum was determined. Mr. Jack Hilgers introduced the guest making a presentation, Andy Schwartz from the Virginia Values Veterans (V3) Program. Their names are recorded above.

Approval of Agenda

Chair Schollmann asked, that if there were no changes, for a motion to approve the agenda (*Attachment 1*). The agenda previously was forwarded to the Foundation members electronically and was in the material distributed.

Mr. Pianalto **moved** to approve the agenda and Mr. Frank Finelli **seconded** the motion. There was no discussion and the motion **passed unanimously**.

Review and Approval of November 6, 2013 Meeting Minutes

Chair Schollmann stated that the November 6, 2013 meeting minutes were previously forwarded to the Foundation members electronically. Hard copies are available if anyone desires to see them.

Chair Schollmann asked if there were any corrections to the Board minutes. Hearing none, he called for a motion to approve the VSF November 6, 2013 Board minutes. Mr. Jack Kavanaugh **moved** to approve the minutes and Mr. Tom Gordy **seconded** the motion. There was no discussion and the motion **passed unanimously**.

Presentation:

Virginia Values Veterans (V3) Program

Mr. Andy Schwartz gave a Presentation on the V3 Program. He explained that the V3 program has gone through some changes. As of March 1st the Virginia Employment Commission (VEC) will be dealing with Veterans directly. Seven veteran representatives from VEC and DVS will be the main agents to train companies and serve as liaisons to qualified veterans, who will participate with the V3 program. DVS entered into a formal Memorandum of Understanding with VEC.

V3 Program Success to Date (since June 2012)

- o 179 Certified Companies
- 5,554 Jobs Pledged to Veterans
- o 3,296 Actual Hires Reported
- o 18 Training Events conducted

Mr. Finelli commented that these results reflect a significant reduction in the pace of job pledges and actual hires achieved in FY13, the first year of the V3 Program.

Mr. Schwartz explained that the V3 program is focusing on companies and getting them connected with qualified veterans. V3 will assist companies recruit, hire, train, and retain a highly-skilled, well-educated, and easily-trained leadership talent pool: Virginia's Veterans.

DVS will launch a state-of-the-art curriculum on July 1, 2014, which will draw from nationwide best practices, and increase the number of qualified, highly-trained V3 representatives from seven to ten.

Mr. Schwartz explained that the funding levels currently proposed on the Governor's proposed budget are sufficient to carry out the operations of the V3 Program. Mr. Finelli highlighted that the DVS-prescribed VSF Goals and Objectives for FY2014 (see <u>Attachment 2</u> to VSF Development Committee minutes of March 26, 2014) include no goals, objectives, or funding requirements relating to veteran hiring. However, if funds are donated to the Foundation for the V3 Program, those funds would be used to help develop and connect qualified veterans to employers.

Chair Schollmann thanked Mr. Schwartz for his presentation.

Chair Schollmann called for a lunch break at 11:55 a.m. He called the meeting back to order at 12:25 p.m.

REPORTS

Board of Veterans Services (BVS) Report

Chair Schollmann stated that Mr. Thad Jones was unable to attend today's meeting and that the BVS Report was included in the materials handed out (*Attachment 2*). BVS met on January 6, 2014. The next meeting is scheduled for Tuesday, May 13.

Joint Leadership Council (JLC) of Veterans Service Organizations Report

Mr. Don Kaiserman said that the JLC Report was included in the materials handed out (*Attachment 3*). Mr. Kaiserman said that the next meeting will be Wednesday, May 21.

Chair Schollmann thanked Mr. Kaiserman for his report.

Department of Veterans Services Report

Deputy Commissioner Cathy Wilson reviewed the DVS report for Commissioner Paul Galanti who is attending a Fundraiser in Norfolk. (*See attachment 4*).

She explained that there is some realignment within DVS. Ms. Annie Walker Director of State Approving Agency is taken on a larger role by adding V3 and VMSDEP programs. The new name for her program is Veterans Education, Training and Employment (VETE).

Deputy Commissioner Wilson expressed the Commissioner's appreciation for the support of the trustees.

Mr. Finelli asked about the percentage of National Guard that are unemployed. Deputy Commissioner Wilson stated that she does not have the accurate numbers, but would try to get those for the next meeting.

Chair Schollmann thanked Deputy Commissioner Wilson for the report.

Foundation Executive Director Report

Mr. Hilgers reviewed the VSF Income (<u>Attachment 5</u>) and Support Fund Expenses (<u>Attachment 6</u>) which were covered during the earlier Finance Committee meeting at which all members were present. He asked if the Board members had any further comments or questions. None were offered.

Mr. Hilgers briefly reviewed the VWWP fundraising events for FY14 (*Attachment 7*) which had need covered earlier during the Development and Finance Committee meetings. He also mentioned the next three Board and Committee meeting dates for 2014. The May 7 meeting will be at the American Legion Building. The August 6 and November 5 meetings will be at the Virginia War Memorial unless construction has started then. If so, the meetings will be moved to the American Legion.

Chair Schollmann thanked Mr. Hilgers for his reports.

Board Chair/ Executive Committee

Chair Schollmann stated that he had no new information to provide except that the Bylaws require the appointment of a Nominating Committee which the Board will elect later in the agenda. The Chair nominated Mr. Bill Lechler, Mr. Pete Trainer and Ms. Juanita Farrow as the Election Committee. Other nominations may be made from the floor later during New Business.

Development Committee

Mr. Jim Boyd reviewed the Development Committee meeting and stated that all, except one member, were present. The Committee recommends the Board approve the 2nd Quarter FY14 Financial Reports and Budget Adjustments.

Finance Committee

Mr. Jack Kavanaugh stated that the Finance Committee met earlier today, Wednesday, March 26 in which all Board members present participated. The Committee recommends the Board approve the 2nd Quarter FY14 Financial Reports and Budget Adjustments.

Veterans Services Fund Quarterly Report

Ms. Tammy Davidson said that she had covered the end of VSF Quarterly Report (<u>Attachment 8</u>) during the Finance Committee meeting of the whole where all were present and asked if there were any additional questions. No questions were posed.

Budget Adjustments

Mr. Hilgers reviewed the Budget Adjustments (<u>Attachment 9</u>), that had been reviewed by the Finance Committee earlier when the whole Board was present. He asked if the Board members had any questions regarding the Budget adjustments. There was no response.

The Joint Leadership Council of Veterans Service Organizations (the JLC) has met three times since the last report to the Veterans Services Foundation (VSF):

- December 18, 2013;
- January 9, 2014 (annual Conference at the General Assembly);
- March 19, 2014.

At the December 18, 2013 meeting, the JLC reviewed the funding levels proposed by Governor McDonnell in his introduced budget. The JLC 2014 Initiatives were revised to account for the funding levels in the introduced budget. A summary of the revised initiatives is attached to this report. JLC position papers for each initiative are available on the JLC page of the Department of Veterans Services (DVS) website.

Two of the JLC initiatives – JLC 2014-04 and JLC 2014-07 – are legislative in nature and were acted upon favorably the 2014 General Assembly. The other five initiatives are budget-related, and their final is dependent on actions taken during the 2014 Special Session.

Subject: Department of Veterans Services report

I am pleased to report to you on some of the recent accomplishments of your Department of Veterans Services (DVS):

- DVS recently realigned several functions under the new Veterans Education, Training, and Employment (VETE) section of DVS. The VETE section is now responsible for:
 - G.I. Bill program certification and audit (the mission of the State Approving Agency for Veterans Education and Training, or SAA);
 - Virginia Values Veterans (V3) Program;
 - Virginia Transition Assistance Program (VTAP);
 - Virginia Military Survivors and Dependents Education Program (VMSDEP).
- Virginia Wounded Warrior Program (VWWP):
 - The Substance Abuse and Mental Health Services Administration (SAMHSA) hosts a series of Implementation Academies for states and territories that have previously participated in a Service Members, Veterans, and their Families (SMVF) Policy Academy. Based on VWWP's strategic work with military and veterans families, the VWWP was asked to attend the March 13-14 meeting in Baltimore, MD. VWWP sent a five-person delegation.
 - The housing development team is working with Virginia Coalition to End Homelessness, U.S. Department of Veterans Affairs (VA) Veterans Integrated Services Network (VISN) 6, Continua of Care leads, VWWP Region V, and the Hampton VA Medical Center to develop an advisory group to plan a regional veteran housing boot camp (target implementation for summer 2014).

- The boot camp is modeled after the National Veteran Housing Boot Camps hosted by Community Solutions/100,000 homes. During the boot camp regional leaders come together to share and prioritize resources for veterans, identify a monthly take down target of housing placements (on pace to end veteran homelessness by 2015), and commit to a 100-day challenge to house as many veterans as possible.
- Veterans care centers:
 - Construction continues on the 40-bed addition to the Sitter & Barfoot Veterans Care Center. Completion is expected in late 2014 with the first new residents expected to be admitted in early 2015;
 - The Virginia Veterans Care Center will receive federal grant funding to replace or upgrade the emergency generator, patient security system, fire alarm system, and communications system;
 - Because of federal funding restrictions, the Hampton and Northern Virginia care center projects will not receive federal grant funding in 2014.
- Veterans cemeteries: several building/grounds maintenance and equipment replacement projects were recently completed or are being planned at the state veterans cemeteries:
 - Completed: two F-150 pickup trucks purchased for the Suffolk cemetery; one rotating front-bed dirt hauler purchased for each cemetery (Amelia, Dublin, and Suffolk);
 - Underway (design stage): heating and cooling systems replacement in the chapel, office building, comfort station, and the grounds maintenance building at the Amelia cemetery;
 - Planning (grant request preparation stage): new columbariums and supporting infrastructure improvements (roads, irrigation, and landscaping) at the Suffolk cemetery;

As always, I would like to thank you for your unflagging devotion in advocating for new and improved services for our veterans and for your support of the Department of Veterans Services. Though it can take several years to reach an objective, we have accomplished great things together, and I look forward to our continued partnership in 2014.


